Fighting

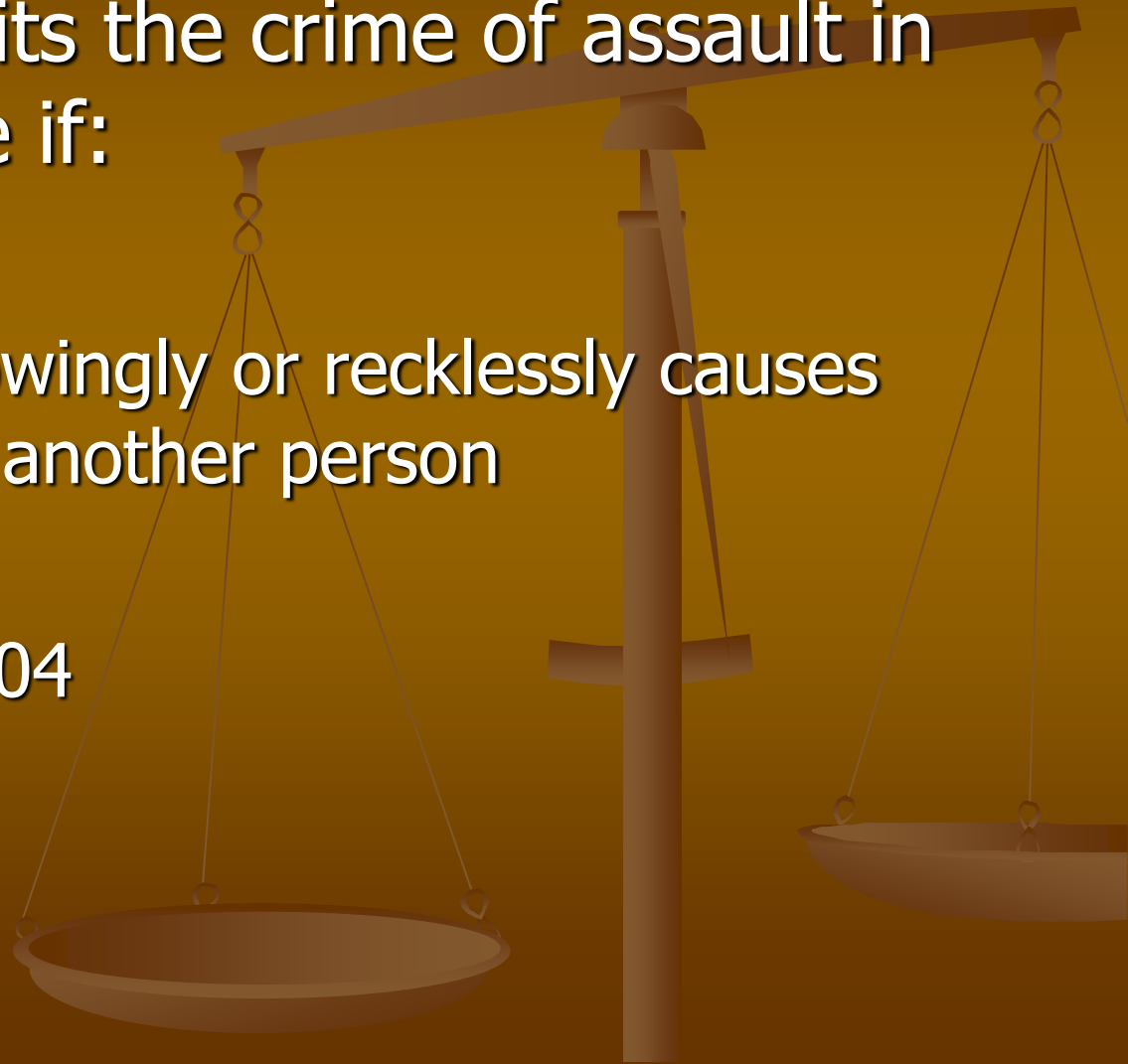


Fighting in Public (Disorderly Conduct)

- A person commits disorderly conduct if he or she intentionally, knowingly, or recklessly:
 - Fights with another in a public place except in an amateur or professional contest of athletic skill
 - C.R.S. § 18-9-106

3rd Degree Assault

- A person commits the crime of assault in the third degree if:
 - The person knowingly or recklessly causes bodily injury to another person
 - C.R.S. § 18-3-204



Harassment

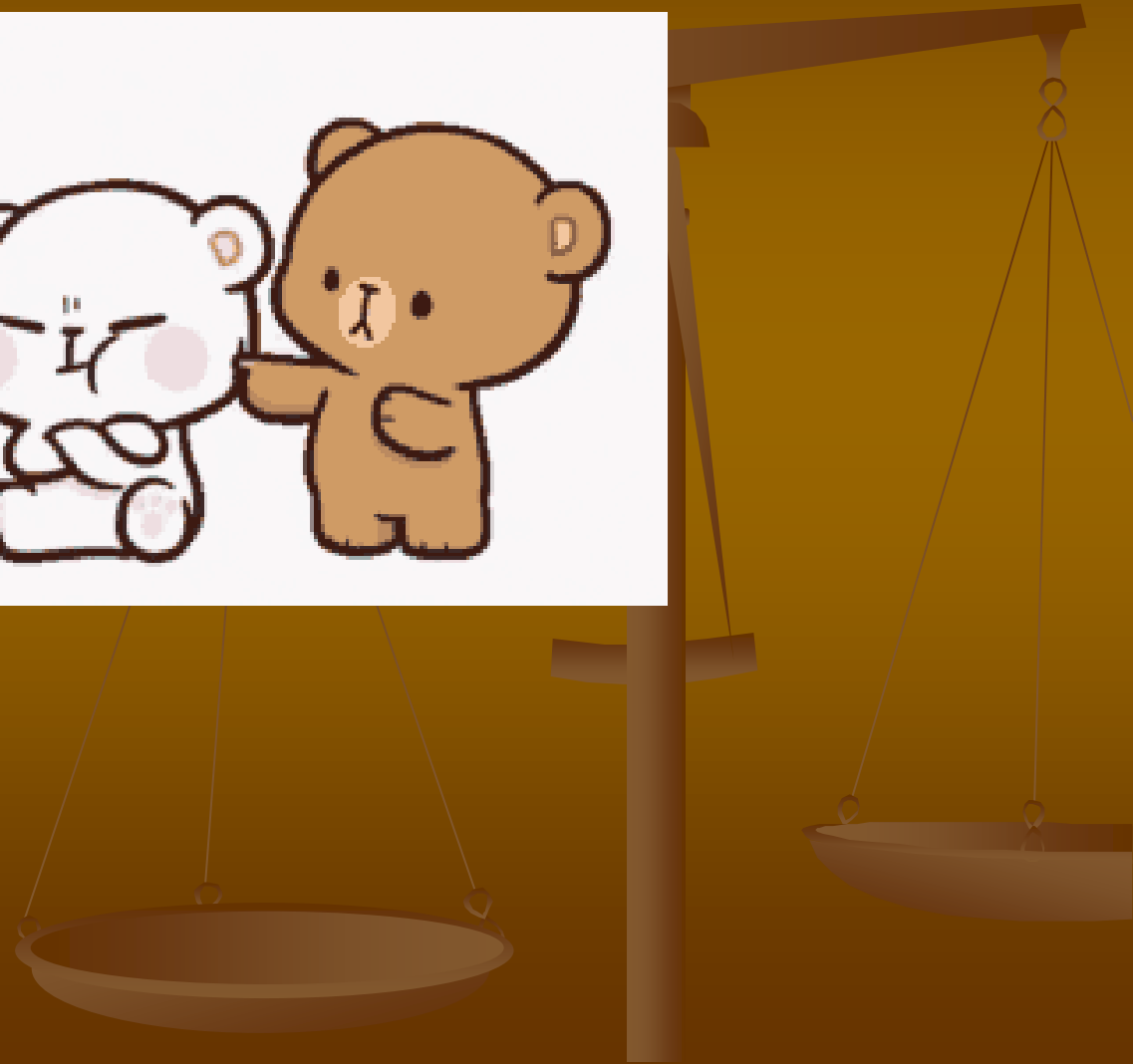


Physical Harassment



- A person commits harassment if, with intent to harass, annoy, or alarm another person, he or she:
 - Strikes, shoves, kicks, or otherwise touches a person or subjects him to physical contact
 - C.R.S. § 18-9-111(1)(a)

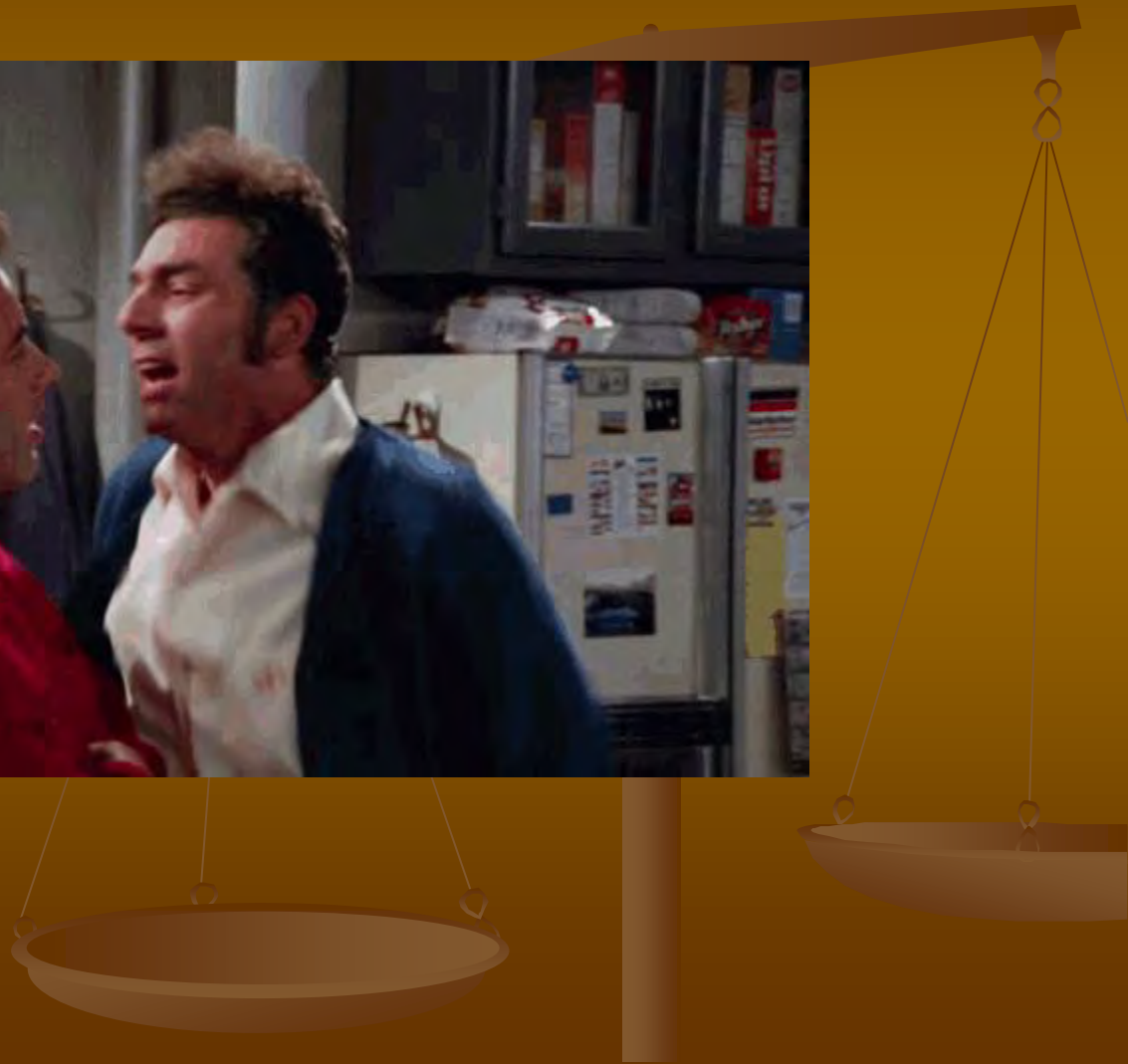


Verbal Harassment

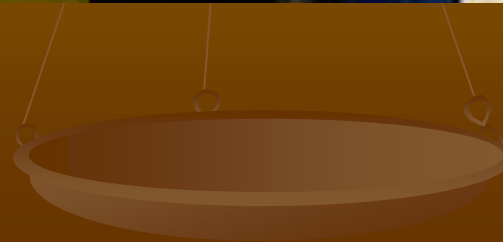


- A person commits harassment if with intent to harass, annoy, or alarm another person, he or she:
 - Repeatedly insults, taunts, challenges, or makes communications in offensively coarse language to, another in a manner likely to provoke a violent or disorderly response.
- C.R.S. § 18-9-111(1)(h)

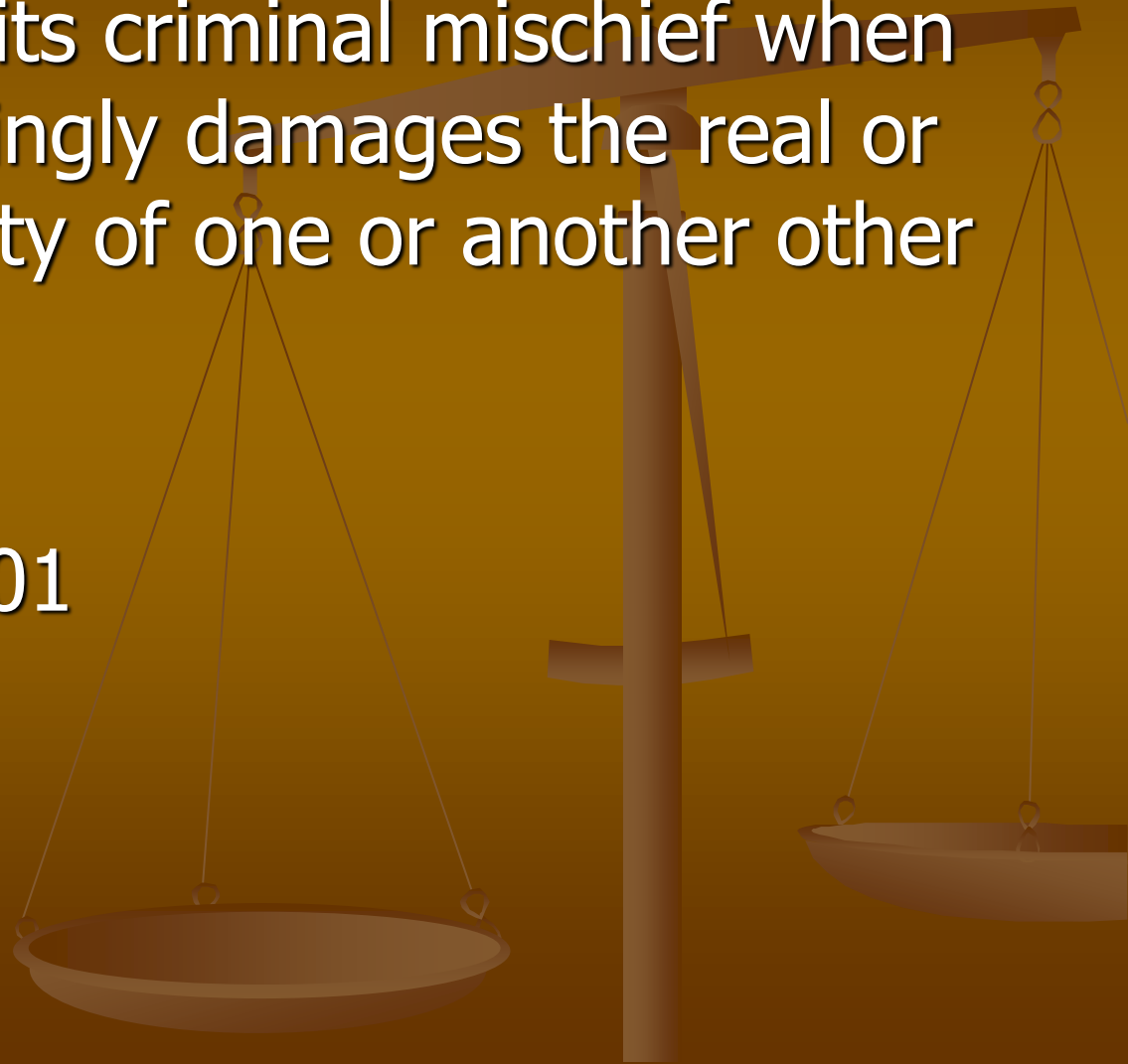


Criminal Mischief

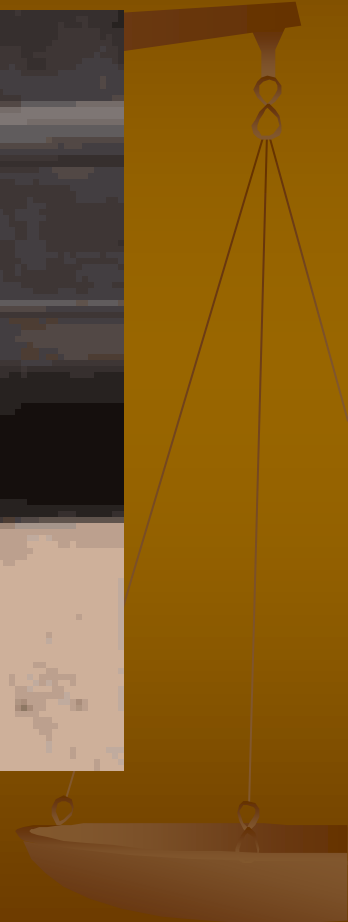
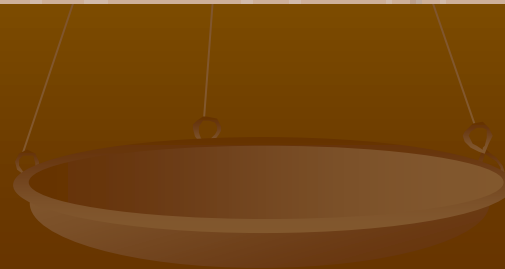


Criminal Mischief

- A person commits criminal mischief when he or she knowingly damages the real or personal property of one or another other persons
- C.R.S. § 18-4-501



Theft



Theft



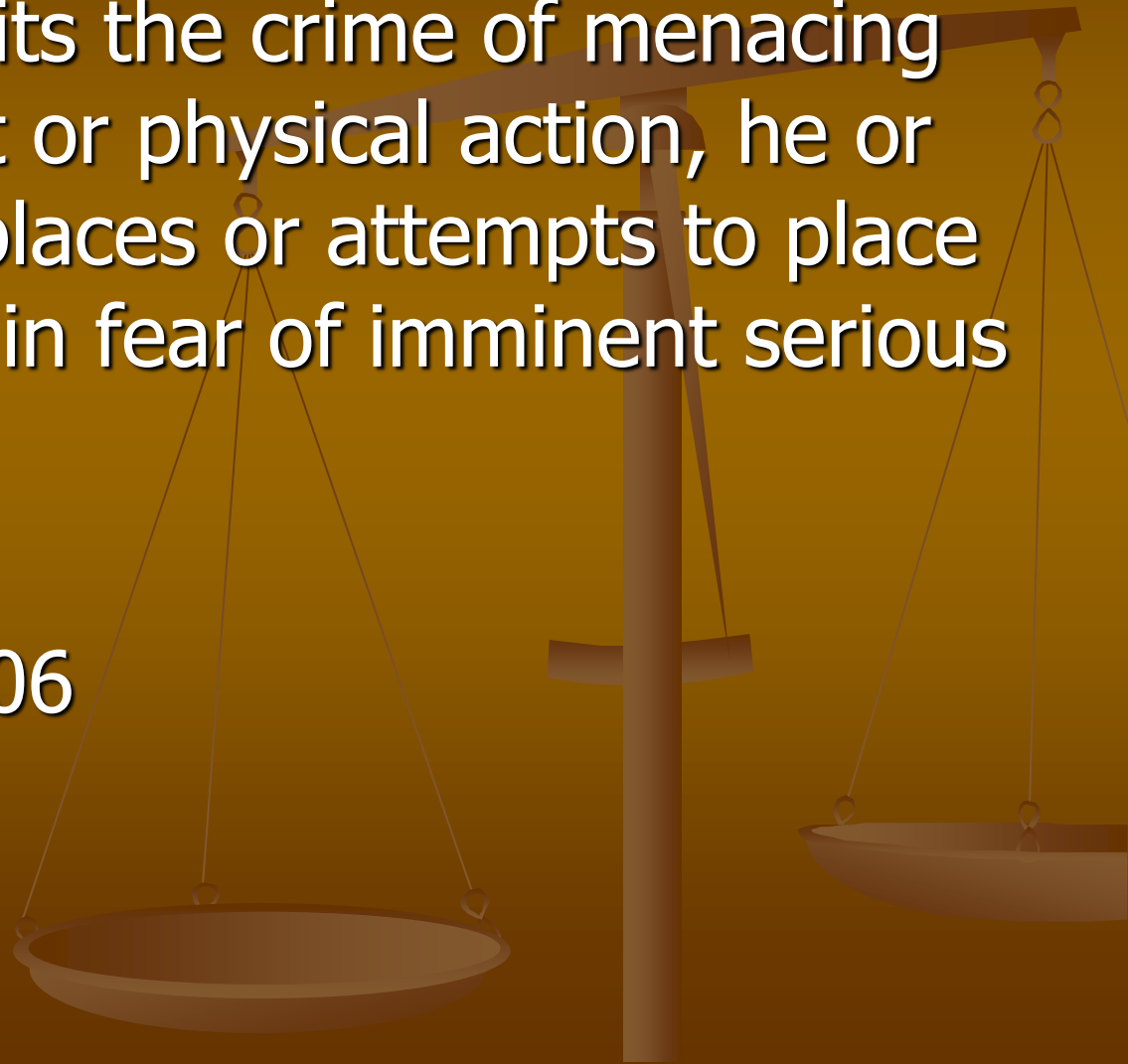
- A person commits theft when he or she knowingly obtains, retains, or exercises control over anything of value of another without authorization or by threat or deception, and:
 - Intends to deprive the other person permanently of the use or benefit of the thing of value
 - C.R.S. § 18-4-401(1)(a)

Menacing



Menacing


- A person commits the crime of menacing if, by any threat or physical action, he or she knowingly places or attempts to place another person in fear of imminent serious bodily injury
- C.R.S. § 18-3-206



Alcohol offenses

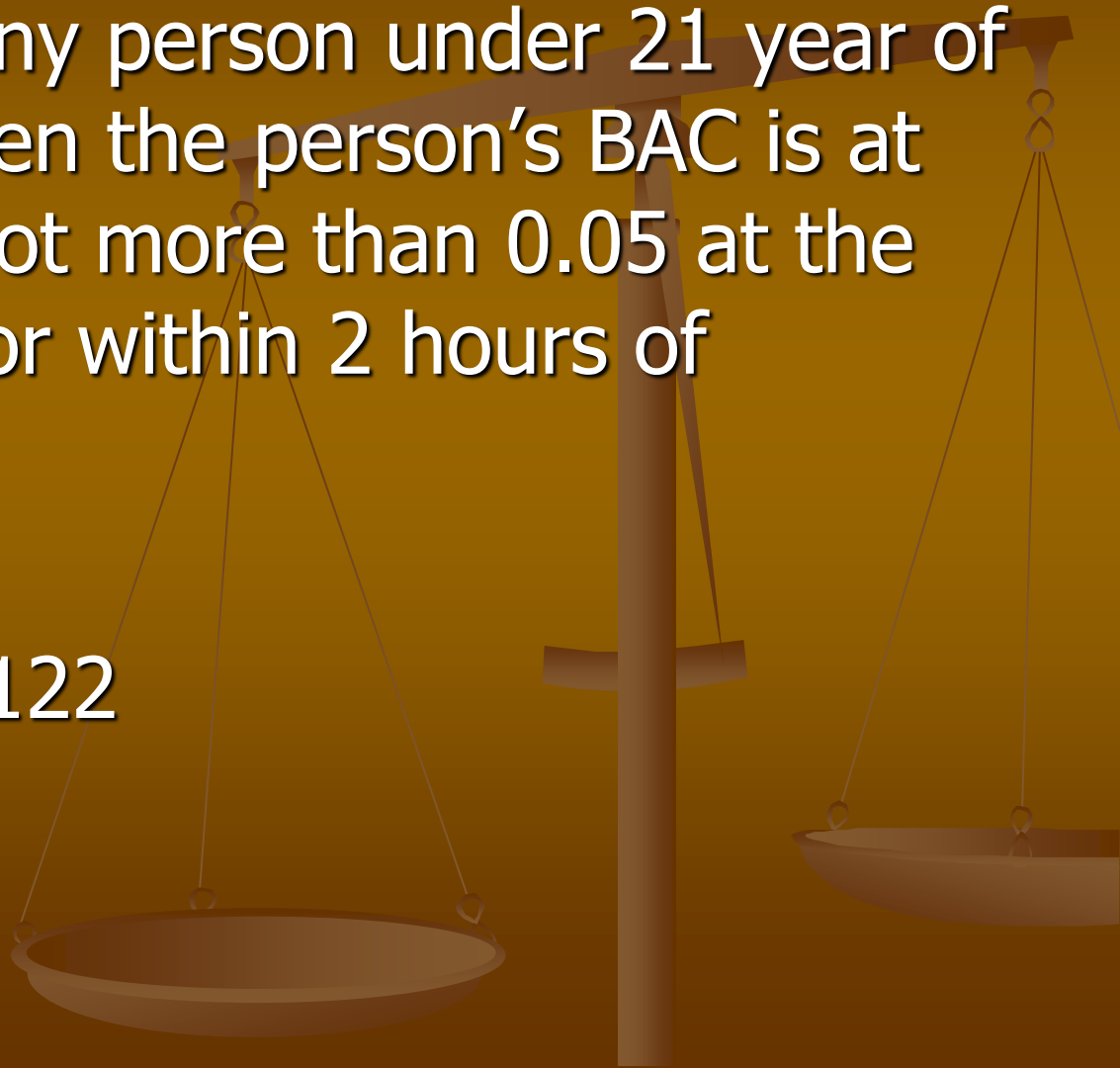


Minor in Possession of Alcohol (MIP)

- Unless there is an exception, a person under 21 years of age who possesses or consumes alcohol anywhere in Colorado commits illegal possession or consumption of alcohol by an underage person.
 - Illegal possession or consumption of ethyl alcohol by an underage person is a strict liability offense.
 - C.R.S. § 18-13-122

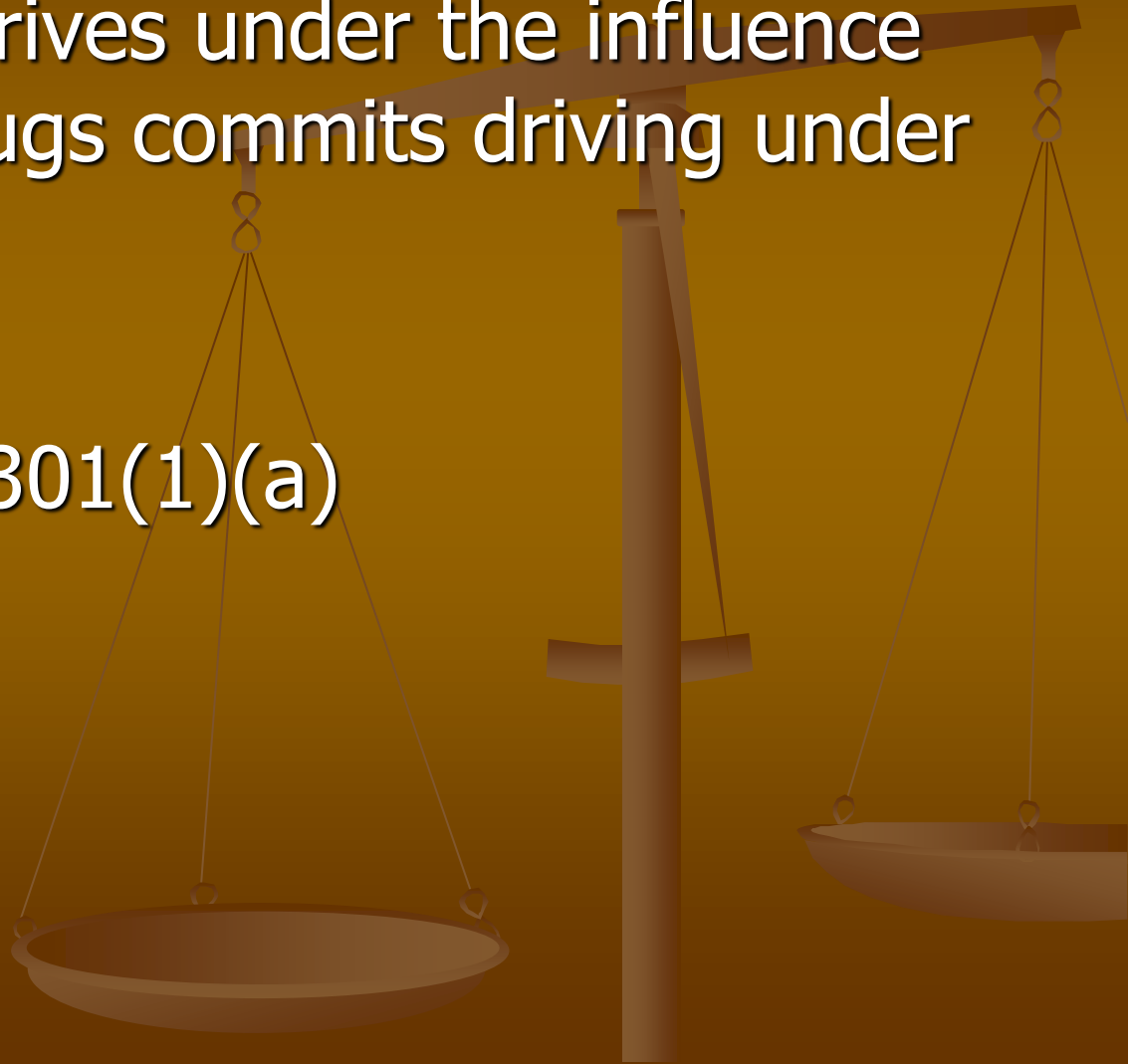
Baby DUI

- It is illegal for any person under 21 year of age to drive when the person's BAC is at least 0.02 but not more than 0.05 at the time of driving or within 2 hours of driving.
- C.R.S. § 18-13-122



DUI

- A person who drives under the influence of alcohol or drugs commits driving under the influence.
- C.R.S. § 42-4-1301(1)(a)

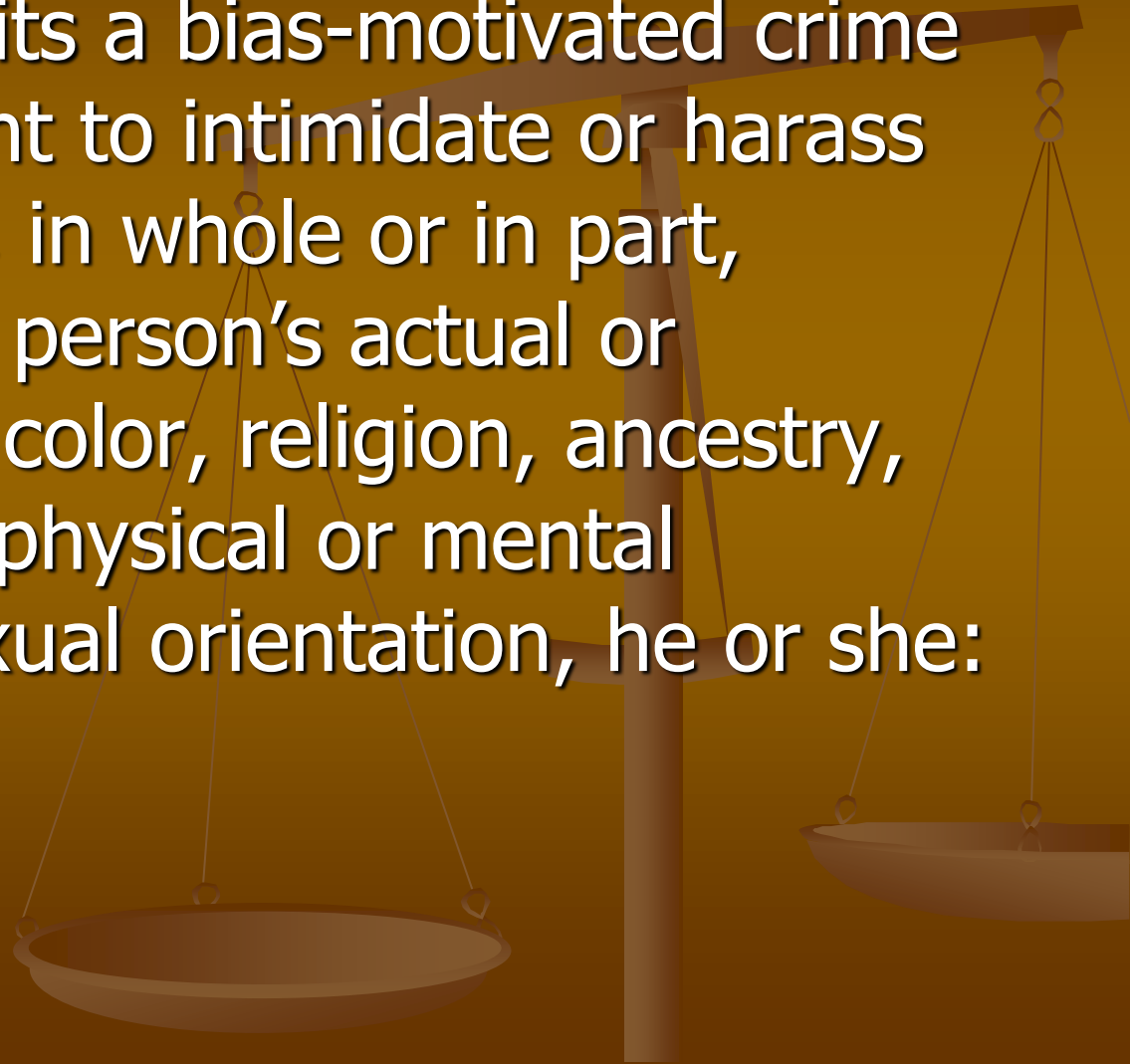


Bias-Motivated Crime



Bias-Motivated Crime

- A person commits a bias-motivated crime if, with the intent to intimidate or harass another person, in whole or in part, because of that person's actual or perceived race, color, religion, ancestry, national origin, physical or mental disability, or sexual orientation, he or she:

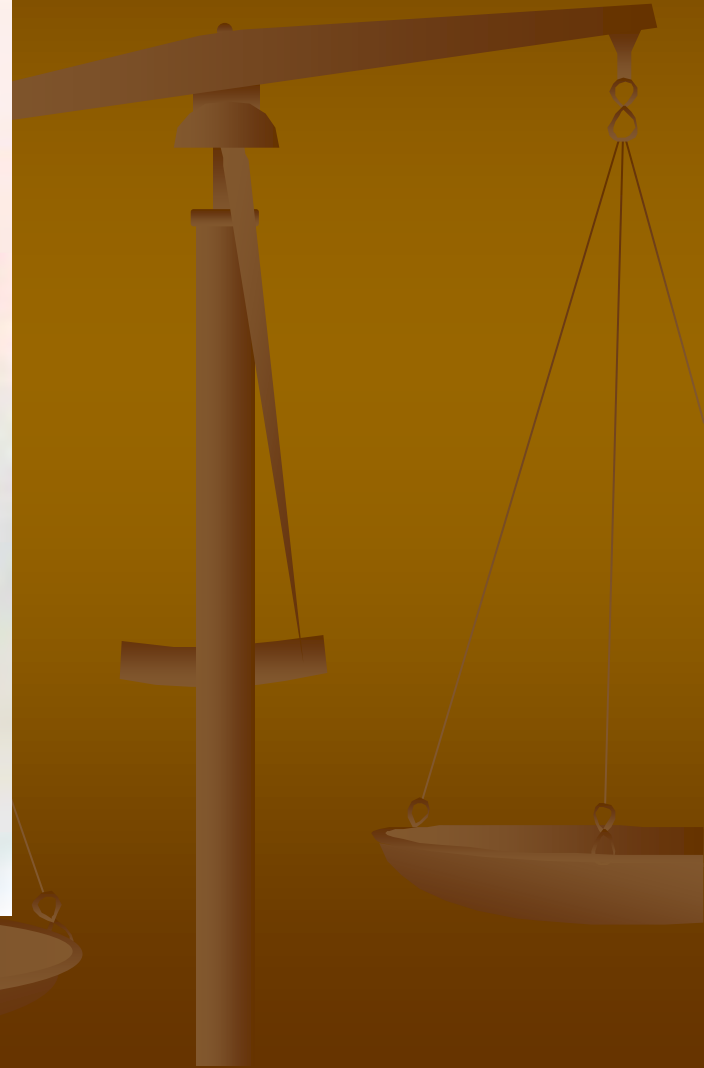


Bias-Motivated Crime



- (a) knowingly causes bodily injury to another person, or
- (b) by words or conduct, knowingly places another person in fear or imminent lawless action directed at that person or that person's property and such words or conduct are likely to produce bodily injury or damage to property, or
- (c) knowingly causes damage to property
- C.R.S. § 18-9-121

Domestic Violence



- Domestic violence means an act or threatened act of violence upon a person with whom the actor is or has been involved in an intimate relationship.
- It also includes any other crime against a person, or against property, including an animal when used as a method of coercion, control, punishment, intimidate or revenge.
- C.R.S. § 18-6-800.3
